DISCUSSION	Mr. Wagner purchased agricultural property on Windfall Road in 1999. This property was platted as a subdivision in 1970. The gas company needs to replace a gas line. The Prosecutor advised Mr. Wagner that if the subdivision is vacated by a petition with the Commissioners the project would be easier to complete. This is a 20" line with 1200 # of pressure. 	First of February Mr. Josh Gibson has requested to take an EMT class. The cost is approximately \$ 1,300 – at Tri-Rivers Vocational School, Marion, OH. He must reimburse the Township if he does not pass the final EMT test. (motion made – 2019-56)
	At this time the department has 14 EMT – 12 are basic, 1 advance and 1 medic.
	Narcan and sterile water is needed – approximate cost \$ 300. The Zoll Cardiac monitor needs to be certified in January – approximate cost of \$ 200. Both items not to exceed total of \$ 500 (motion made – 2019-57)
	Dave Garrett requested an EMS billing Resolution – the same as was passed a year ago. Mr. Garrett is applying for Medicare bill license. The fee is \$ 531 and will be deducted from billing proceeds upon the set-up of the system. Electronic Reporting for transports was discussed. At this time the number of transports does not warrant the cost of electronic over paper filing. (Resolution passed – JT2019-58) This 4-year Contract will be on file at the Fire Department and a copy in the Fiscal Officer office upon completion of the application. Mr. Garrett is the lead person on this project.
